



## Introduction

This guide is refers to the CAP-A pilot run by Bora IT Security Marketing.

The **purpose** of this pilot is to raise privacy awareness for mobile apps. Participants in this pilot can explore the privacy behaviour of mobile apps and participate actively in the privacy evaluation of apps through a set of crowdsourcing activities.

The **objective** of the pilot is to evaluate how privacy-friendly are popular Android apps and to measure the level of trust users place on these apps. The results of this pilot will be communicated to app developers to foster an ecosystem of apps respecting the privacy of their users. You may find more details on the EU-funded project <u>here</u>.

The pilot focuses on popular **business** apps, including project management, browsing, communication and collaboration tools.

# Steps and Tasks

**Note**: All tasks are part of the CAP-A reward mechanism, giving pilot participants points upon completion.

### Registration

Before expressing your opinion, you will have to register to the CAP-A community. To do so, click on the Login/Register option on the left-hand-side menu. You will be asked to provide a working email and a password.

### **Profile information**

Upon registration, you may fill in some information about yourself by clicking on the Profile option on your left-hand-side menu. This will grant you **50 points**.

### **Favourite Apps**

After logging in, declare at least **5 favourite apps.** Type in the name of your favourite apps in the Search apps field at the top of the portal. In the app page, click the green button with the heart icon.

This action will reward you with another **50 points** and is required to unlock the following tasks. The more apps you add in your favourites lists, the more points you gain.

### **Privacy Expectations**

In this task you will express your opinion whether the permissions of each app seem reasonable to you or not. Select one of the participating apps and then go to the **Permissions** tab.

There you can see the required permissions per app, and you can express for permission your expectation. This can be done by clicking on the Yes/No slider.



You will need to express the expectations for as many apps and permissions possible to earn **300 points or more** and unlock the next step.

### **Privacy Policy Annotations**

The second task you can do is to annotate the app permissions with content from the app privacy policy.

To do that, after your select an app from the **Bora Pilot**, click on the **Permissions** tab. On the Permissions tab, click to show the **Annotator too**l.



You can do either annotate the app permissions or the privacy policies.

- 1. Select a paragraph (it gets highlighted in yellow)
- 2. Click either on the respective permission or policy.
